**Event Description:**

On Tuesday, 7/31/07, 1:50AM, a 32 y/o female complainant was inside her residence in the 200 block of Carpenter St. when an unknown male entered through a rear screen door. The offender demanded money and, after a struggle, sexually and physically assaulted the complainant, then fled the residence carrying a 5lb weight taken from inside the property.

**NOTE:** Two additional incidents bear similarities to the above incident by virtue of the offender description, modus operandi, and, or nature of the offense.

**HOME INVASION- ATTEMPT RAPE**  
**200 BLK CARPENTER STREET**

On Tuesday, 7/31/07 at about 1:50AM, a 32 year-old female was assaulted inside of her residence by an unknown assailant.

The complainant, who had arrived home from vacation at about 1AM, opened her 1<sup>st</sup> floor siding glass door to let some air in while she unpacked her bags. A short time later she noticed the screen door was open. The assailant then appeared demanding money, when she told him she didn't have any, he told her take off her pants. She refused and he forced her into the bedroom, pulled down her pants and indecently assaulted her. The complainant picked up a 5 lb dumbbell to defend herself but the assailant took it from her and hit her on the head with it, before fleeing. She was taken to Jefferson hospital for treatment for an abrasion to her head and will be released.

The assailant is described as a black male, 20-30 yrs, 5'7", muscular build, dark complexion, thin beard; wearing a black tee shirt and black jeans. He fled with the red & white 5 lb dumbbell.

The scene was processed by the Crime Scene Unit. Neighborhood interviews were conducted. The investigation is continuing.

**BURGLARY-INDECENT ASSAULT**
