



# WANTED MURDER/RAPE



The male portrayed in this wanted poster is responsible for three (3) rapes and one rape/murder occurring from April 30<sup>th</sup>, 2003 to the latest attack that occurred on August 11<sup>th</sup>, 2007. DNA evidence has confirmed that the same individual is responsible for each attack. These attacks took place in park settings against females who were jogging or walking in the area(s).

Case #1: 4/30/03, Kelly Drive/Fountain Green Rd. Rape.

Case #2: 7/13/03, 3500 Conshohocken. Rape/Murder.

Case #3: 10/25/03, West River Drive, near Falls Bridge. Attempt Rape.

Case #4: 8/11/07, Frankford & Solly, in park. Rape.

The offender is described as a Hispanic male with a heavy accent, medium and muscular build, about 5'8" tall, dark complexion, black hair with a thin mustache or jaw line beard and bushy eyebrows. Also described as having a 'widow's peak' hair line. In two cases, wearing an earring in left ear. He has been seen fleeing scene(s) on a purple metallic 10-speed bike.

## **FAIRMOUNT/PENNYPACK PARK PATTERN**

Using DNA profiling, a pattern of sexual assaults and a murder have been attributed to a single unknown male. The earlier assaults took place between April 30<sup>th</sup>, 2003 and October 25<sup>th</sup>, 2003.

The latest assault took place in Pennypack Park on 8/11/07. DNA evidence recovered in this attack has been definitively linked to the same individual. The following is a brief synopsis of these attacks:

### **4/30/2003    10:30PM    Kelly Drive & Fountain Green Rd**

21 year-old female jogger accosted by offender who was armed with a knife. The complainant was forced from the jogging path to the river edge where she was threatened and raped. Offender description: Hispanic male, 5'7", in his 20's; medium build and 'strong'; earring in left ear, dark hair with widow's peak. Last seen fleeing scene on metallic 10-speed bike.

### **7/13/2003    5:00PM    3500 Conshohocken (woods)**

30 year-old female went jogging on 7/13/07 and did not return. Detectives searching wooded area near her house find her remains. Victim was strangled and raped. Interviews of other joggers result in description of suspect who had been seen in the area: Hispanic male, 25 years old, 5'7"; black hair; medium build with an olive complexion and a thin mustache. Also seen wearing a gold earring in left ear.

### **10/25/2003    6:15PM    Lot #2, West River Drive**

37 year-old female accosted while jogging ¼ mile south of Falls Bridge by offender armed with a knife. Subject attempts to drag her to river edge, but victim fights back and sustains puncture and defensive wounds to neck, chest and hand. Prior to the attack, victim recalls seeing offender riding a metallic purple 10 speed bike with curved handlebars. Offender description: Hispanic male, in his 20's, 5'8", thin mustache and dark hair with a widow's peak.

### **8/11/2007    8:00PM    Frankford & Solly (in park)**

29 year-old female walking in Pennypack Park is accosted by an unknown male who drags her into a wooded and secluded area where he rapes and robs her. No weapon used. Offender description: Hispanic male with a heavy accent, 25 years, 5'5" to 5'7" tall, medium and muscular build, dark complexion with a short jaw line beard/goatee and bushy eyebrows. He was wearing a sky blue basketball jersey, white shorts and a gold chain.

DNA analysis of evidence recovered has linked each assault to the same unknown individual. Available suspect composites have been distributed.
